The purpose of this document is to confirm that our company is aware of the **European Union Timber Regulation** (EUTR No: 995/2010) and meets the compliance obligations.

All fibre raw materials used in the division have been harvested and procured in compliance with the EUTR as well as with applicable laws in the country of harvesting. Controversial sources are eliminated. All fibre raw materials used at our mills are either certified or controlled.
